

## PUBLIC NOTICE

### SALE OF ADULTERATED FUEL AND DUMPING OF EXPORT (TRANSIT) MOTOR FUELS IN THE LOCAL MARKET

The Energy Regulatory Commission (the Commission) is empowered by Section 95 of the Energy Act, No 12 of 2006 (the Act) to monitor the sale of adulterated petroleum products in the local market and dumping of petroleum products intended for export. In this regard, the Commission undertakes a program of continuous monitoring of the quality of petroleum motor fuels being sold throughout the country.

During the months of August, September, October and November 2014, a total of **3,010** tests were carried out in **526** petroleum outlets. **99%** of the tests were compliant. However, **twenty-three (23) tests** from **fourteen (14) sites** were non-compliant as detailed hereunder:

Respective County Commissioners were requested to withdraw the licenses of operators of the defaulting outlets. In addition, defaulters were required to pay penalties and taxes in accordance with the applicable laws, before resumption of business.
